# THE CORK COUNTY DIVIDING ORDER, 1934.

(Reference is made to this order ante p. 242).

WHEREAS before the passing of the Local Government (Amendment) (No. 2) Act, 1934 (in this Order referred to as "the Act"), the Council of the County of Cork did request the Minister for Local Government and Public Health (in this Order referred to as the "Minister") to make in pursuance of the Act, a dividing order declaring that there should be, as from the commencement

of such order three rural sanitary districts in the said county and specifying and appointing the other matters referred to in section 5 of the Act:

AND WHEREAS by paragraph (d) of section 8 of the Act it is provided that, when the Minister has made a dividing order in relation to a county, the distinguishing name of each of the rural sanitary districts constituted in such county by virtue of such dividing order shall be such distinguishing name as the Minister shall direct:

NOW, THEREFORE, the Minister in exercise of the powers conferred on him by the said sections 5 and 8 of the Act, hereby orders as follows, that is to say:—

- 1. This Order may be referred to as "The Cork County Dividing Order, 1934".
- 2. The appointed day for the purposes of this Order shall be the 1st day of April, 1935.
- 3. As and from the appointed day there shall be three rural sanitary districts in the County of Cork, which shall be distinguished respectively by the following names, that is to say:—
  - (1) The North Cork county health district;
  - (2) The South Cork county health district; and
  - (3) The West Cork county health district.
- 4. The portion of the County of Cork which is to be included in and constitute the North Cork county health district shall consist of the areas of the rural districts which are set forth in Part I of the Schedule to this Order, as constituted immediately before the 1st day of October, 1925.
- 5. The portion of the county of Cork which is to be included in and constitute the South Cork county health district shall consist of the areas of the rural districts which are set forth in Part II of the Schedule to this Order, as constituted immediately before the 1st day of October 1925.
- 6. The portion of the county of Cork which is to be included in and constitute the West Cork county health district shall consist of the areas of the rural districts which are

set forth in Part III of the Schedule to this Order, as constituted immediately before the 1st day of October, 1925.
