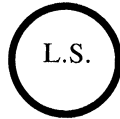
The Government, in exercise of the powers conferred by section 5 of the National Treasury Management Agency Act 1990 (No. 18 of 1990), hereby order as follows:

2. —The functions of the Minister for Finance under section 54(7E) of the Finance Act 1970 (inserted by the National Asset Management Agency Act 2009 (No. 34 of 2009)) are delegated to the National Treasury Management Agency.
