(a) le hAchtanna an Oireachtais nó leis na reachtanna a bhí i bhfeidhm i Saorstát Éireann díreach roimh an dáta a tháinig an Bunreacht i ngníomh agus a lean i bhfeidhm de bhua Airteagal 50 den Bhunreacht, nó fúthu, ar Achtanna nó reachtanna iad a shonraítear i gCuid 1 den Sceideal,

(b) le forálacha na nAchtanna den Oireachtas a shonraítear i gCuid 2 den Sceideal, nó fúthu, agus

(c) faoi fhorálacha na Rialachán a shonraítear i gCuid 3 den Sceideal,

a tharmligean chuig Seosamh Mac Aodha, Aire Stáit ag an Roinn Ealaíon, Oidhreachta, Gnóthaí Réigiúnacha, Tuaithe agus Gaeltachta.

(DELEGATION OF MINISTERIAL FUNCTIONS) ORDER 2017

The Government, on the request of the Minister for Arts, Heritage, Regional, Rural and Gaeltacht Affairs (as adapted by the Arts, Heritage and the Gaeltacht (Alteration of Name of Department and Title of Minister) Order 2016 (S.I. No. 357 of 2016)), and in exercise of the powers conferred on them by section 2(1) of the Ministers and Secretaries (Amendment) (No. 2) Act 1977 (No. 28 of 1977), hereby orders as follows:

1. This Order may be cited as the Arts, Heritage, Regional, Rural and Gaeltacht Affairs (Delegation of Ministerial Functions) Order 2017.
2. The powers and duties of the Minister for Arts, Heritage, Regional, Rural and Gaeltacht Affairs conferred on her—
  - (a) by or under the Acts of the Oireachtas or statutes which were in force in Saorstát Éireann immediately before the date of the coming into operation of the Constitution and which continued in force by virtue of Article 50 of the Constitution specified in Part 1 of the Schedule,
  - (b) by or under the provisions of the Acts of the Oireachtas specified in Part 2 of the Schedule, and
  - (c) under the provisions of the Regulations specified in Part 3 of the Schedule,

are delegated to Joe McHugh, Minister of State at the Department of Arts, Heritage, Regional, Rural and Gaeltacht Affairs.

## EXPLANATORY NOTE

*(This note is not part of the Instrument and does not purport to be a legal interpretation.)*

The Ministers and Secretaries (Amendment) (No.2) Act, 1977, provides, inter alia, for the delegation of powers and duties from Ministers to Ministers of State by way of a Government Order. Such Orders are normally made where a Minister of State is expected to carry out statutory functions on behalf of a Minister. It should be noted that every power or duty delegated continues to be vested in the Minister of the Government concurrently with the Minister of State and may be exercised or performed by either. This Order provides for the delegation of functions relating to the Irish Language, Gaeltacht and Islands by the Minister for Arts, Heritage, Regional, rural and Gaeltacht Affairs and the Gaeltacht to Minister of State with responsibility for Gaeilge, Gaeltacht and the Islands
