Regulation of Utilities

The Commission for Regulation of Utilities, having received and considered a request made to it by Ervia and, in exercise of the powers conferred on it by Section 2 of the Gas (Amendment) Act 1987, hereby orders as follows:

Citation.

1. This Order may be cited as the Gas (Amendment) Act 1987 (Section 2) (Distribution) (Amendment) Order 2018.

Interpretation.

2. In this Order, “Principal Order” means Gas (Amendment) Act 1987 (Section 2) (Distribution) Order 2003 (S.I. No. 196 of 2003) as amended by Gas (Amendment) Act 1987 (Section 2) (Distribution) (Amendment) Order 2008 (S.I. No. 47 of 2008) and the Gas (Amendment) Act 1987 (Section 2) (Distribution) (Amendment) Order 2015 (S.I. No 59 of 2015).

Commencement

3. This Order shall come into operation on 26 January 2018.
