Rules of the Superior Courts (Service) (No. 2) 2019

Rules of the Superior Courts (Service) (No. 2) 2019

- 1. (1) These Rules, which may be cited as the Rules of the Superior Courts (Service) (No. 2) 2019, shall come into operation on the 15th day of April 2019.
- (2) These Rules shall be construed together with the Rules of the Superior Courts.
- (3) The Rules of the Superior Courts as amended by these Rules may be cited as the Rules of the Superior Courts 1986 to 2019.
- 2. The Rules of the Superior Courts are amended by the substitution in rule 1 of Order 11D for the definition of "transmitting agency" of the following definition:

""transmitting agency" means, as regards the State, the Combined Court Office situate at Castlebar in the County of Mayo or such other authority, or public officer or other person as is for the time being designated by the State pursuant to Article 2(1) of Regulation No. 1393/2007."

EXPLANATORY NOTE
