European Union (Detailed Technical Measures Designation) (Amendment)  
Regulations 2019

I, PASCAL DONOHOE, Minister for Finance, in exercise of the powers conferred on me by section 3 of the European Communities Act 1972 (No. 27 of 1972) and for the purpose of giving full effect to Articles 10 to 15 of Regulation (EU) No 1095/2010 of the European Parliament and of the Council of 24 November 2010<sup>1</sup> and the Commission Regulations mentioned in Regulation 2, hereby make the following regulations:

**Citation**

1. These Regulations may be cited as the European Union (Detailed Technical Measures Designation) (Amendment) Regulations 2019.

**Amendment of Schedule 10 to Central Bank Act 1942**

2. Schedule 10 (amended by Regulation 54 of the European Union (Insurance Distribution) Regulations 2018 (S.I. No. 229 of 2018)) to the Central Bank Act 1942 (No. 22 of 1942) is amended –

- (a) in paragraph (84), by substituting for “21 September 2017;” for “21 September 2017.”, and
- (b) by inserting, after paragraph (84), the following paragraphs:
