PUBLIC HEALTH (ALCOHOL) (FIXED PAYMENT NOTICE) REGULATIONS 2019

- I, SIMON HARRIS, Minister of Health, in exercise of the powers conferred on me by sections 5 and 29 of the Public Health (Alcohol) Act (No. 24 of 2018), hereby make the following regulations:
- 1. (1) These Regulations may be cited as the Public Health (Alcohol) (Fixed Payment Notice) Regulations 2019.
- (2) These Regulations shall come into operation on the 12th day of November 2019.
- 2. In these Regulations, "Act of 2018" means the Public Health (Alcohol) Act 2018 (No. 24 of 2018).
- 3. The form set out in the Schedule is prescribed for the purposes of section 29(1) of the Act of 2018.
- 4. The amount of $\in 1,000$ is prescribed, for the purposes of section 29(1)(c) of the Act of 2018, in relation to a relevant offence alleged to have been committed under paragraph (a), (b) or (c) of subsection (1) of section 17 of the Act of 2018.

These Regulations prescribe the form of a fixed payment notice under the Public Health (Alcohol) Act 2018 (No. 24 of 2018) and the fixed payment payable in respect of the offence under that Act.

These Regulations may be cited as the Public Health (Alcohol) (Fixed Payment Notice) Regulations 2019 and come into operation on 12th November 2019.
