FOOD SAFETY AUTHORITY OF IRELAND ACT 1998 (AMENDMENT
OF FIRST SCHEDULE) ORDER 2022

I, FRANK FEIGHAN, Minister of State at the Department of Health, in exercise of the powers conferred on me by section 5 of the Food Safety Authority of Ireland Act 1998 (No. 29 of 1998) (as adapted by the Health and Children (Alteration of Name of Department and Title of Minister) Order 2011 (S.I. No. 219 of 2011) and the Agriculture, Fisheries and Food (Alteration of Name of Department and Title of Minister) Order 2011 (S.I. No. 455 of 2011)) and the Health (Delegation of Ministerial Functions) (No. 3) Order 2020 (S.I. No. 599 of 2020), after consultation with the Minister for Agriculture, Food and the Marine, hereby order as follows:

1. This Order may be cited as the Food Safety Authority of Ireland Act 1998 (Amendment of First Schedule) Order 2022.

2. Part III of the First Schedule (as amended by Article 3 of the Food Safety Authority of Ireland Act 1998 (Amendment of First Schedule) (No. 2) Order 2021 (S.I. No. 543 of 2021)) to the Food Safety Authority of Ireland Act 1998 (No. 29 of 1998) is amended—
