DISTRICT COURT DISTRICTS AND AREAS (AMENDMENT) AND VARIATION OF DAYS AND HOURS (CARRICK-ON-SUIR, CASHEL, CLONMEL, DUNGARVAN, LISMORE AND YOUGHAL) ORDER, 2022

The Courts Service, in exercise of the powers conferred on it by section 26 of the Courts of Justice Act 1953 (No. 32 of 1953), as amended by section 43 of the Courts (Supplemental Provisions) Act 1961 (No. 39 of 1961), section 16 of the Courts Act 1971 (No. 36 of 1971) and section 29 of the Courts Service Act 1998 (No. 8 of 1998) and after consultation with the President of the District Court, hereby orders as follows:

1. (a) This Order may be cited as the District Court Districts and Areas (Amendment) and Variation of Days and Hours (District No. 21 - Youghal, Carrick-on-Suir, Cashel, Clonmel, Dungarvan and Lismore) Order 2022.
- (b) This Order shall come into operation on 1st day of January 2023.

- (c) the substitution at reference number 231 for the matters in column (4) of the following: “Clonmel - First, second, third and fourth Tuesday in each month at 10.30 a.m. and the fourth Thursday in each month at 10.30 a.m.”, and
- (d) the substitution at reference number 240 for the matters in column (4) of the following: “Dungarvan - Second, third and fourth Monday in each month at 10:30 a.m.”, and
- (e) the substitution at reference number 242 for the matters in column (4) of the following: “Lismore (sitting at Dungarvan) - First Monday in each month at 10:30 a.m.”, and
- (f) the substitution at reference number 54 for the matters in column (4) of the following: “Youghal - Second and fourth Wednesday in each month at 10.30 a.m.”, and
