I, NOEL DEMPSEY, Minister for Communications, Marine and Natural Resources, in exercise of the powers conferred on me by section 43 of the Broadcasting Act 2001 (No. 4 of 2001) and the Broadcasting (Transfer of Departmental Administration and Ministerial Functions) Order 2002 (S.I. No. 299 of 2002) (as adapted by the Marine and Natural Resources (Alteration of Name of Department and Title of Minister) Order 2002 (S.I. No. 307 of 2002)) hereby order as follows:

1. This Order may be cited as the Teilifis na Gaeilge (Establishment Day) Order 2007.
