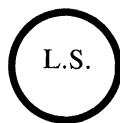

REGULATIONS 2008

I, BRENDAN SMITH, Minister for Agriculture, Fisheries and Food, in exercise of the powers conferred on me by section 3 of the European Communities Act 1972 (No. 27 of 1972) and for the purpose of giving effect to Commission Decision 2008/297/EC of 27 March 2008<sup>1</sup>, hereby make the following regulations—

1. These Regulations may be cited as the European Communities (Swine Vesicular Disease) (Restriction on Imports from Italy) (Amendment) Regulations 2008.

2. The European Communities (Swine Vesicular Disease) (Restriction on Imports from Italy) Regulations 2007 (S.I. No. 71 of 2007) are amended in Regulation 2(1) by the substitution for the definition of “Commission Decision” of—

“ ‘Commission Decision’ means Commission Decision No 2005/779/EC of 8 November 2005; Commission Decision 2007/9/EC of 18 December 2006 and Commission Decision 2008/297/EC of 27 March 2008;”.
