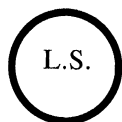
APPOINTMENT OF SPECIAL ADVISERS (MINISTER FOR
ENTERPRISE, TRADE AND EMPLOYMENT) ORDER 2008

The Government, on the request of the Minister for Enterprise, Trade and Employment and in exercise of the powers conferred on them by section 11(1) of the Public Service Management Act 1997 (No. 27 of 1997), hereby order as follows:

1. This Order may be cited as the Appointment of Special Advisers (Minister for Enterprise, Trade and Employment) Order 2008.
