I, MARY HARNEY, Minister for Health and Children, in exercise of the powers conferred on me by section 1(3) of the Medical Practitioners Act 2007 (No. 25 of 2007), hereby order as follows:

1. This Order may be cited as the Medical Practitioners Act 2007 (Commencement) Order 2010.

2. The 1st day of May 2010 is appointed as the day on which the Medical Practitioners Act 2007 (No. 25 of 2007) (except insofar as it is already in operation) comes into operation.

EXPLANATORY NOTE
