FERMOY) ORDER, 2010

The Courts Service, in exercise of the powers conferred on it by section 26 of the Courts of Justice Act, 1953 (No. 32 of 1953), as amended by section 43 of the Courts (Supplemental Provisions) Act, 1961 (No. 39 of 1961), section 16 of the Courts Act, 1971 (No. 36 of 1971) and section 29 of the Courts Service Act, 1998 (No. 8 of 1998) and after consultation with the President of the District Court, hereby orders as follows:

1. (a) This Order may be cited as the District Court Districts and Areas (Amendment) and Variation of Days and Hours (Ballinrobe, Castlebar, Cobh, Midleton, Kanturk, Mallow, Mitchelstown and Fermoy) Order, 2010.
 - (b) This Order shall come into operation on 1st September, 2010.

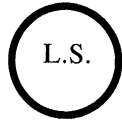

(This note does not form part of the Instrument and is not a legal interpretation.)

This order provides for:

- (a) the amalgamation of the Electoral Divisions of the District Court Area of Ballinrobe into the District Court Area of Castlebar,
- (b) the amalgamation of the Electoral Divisions of the District Court Area of Cobh into the District Court Area of Midleton,
- (c) the amalgamation of the Electoral Divisions of the District Court Area of Kanturk into the District Court Area of Mallow,
- (d) the amalgamation of the Electoral Divisions of the District Court Area of Mitchelstown into the District Court Area of Fermoy, and
- (e) the variation of sittings in Castlebar, Midleton, Mallow and Fermoy.
