EUROPEAN COMMUNITIES (RESTRICTIVE MEASURES AGAINST CERTAIN PERSONS AND ENTITIES ASSOCIATED WITH USAMA BIN LADEN, THE AL-QAIDA NETWORK AND THE TALIBAN) (AMENDMENT) REGULATIONS 2011

I, MARY HANAFIN, Minister for Enterprise, Trade and Innovation, in exercise of the powers conferred on me by section 3 of the European Communities Act 1972 (No. 27 of 1972) and for the purpose of giving full effect to Council Regulation (EC) No. 881/2002 of 27 May 2002<sup>1</sup> as last amended by Commission Regulation (EU) No. 36/2011 of 18 January 2011<sup>2</sup>, hereby make the following regulations:

1. These Regulations may be cited as the European Communities (Restrictive Measures against Certain Persons and Entities Associated with Usama bin Laden, the Al-Qaida Network and the Taliban) (Amendment) Regulations 2011.

2. In these Regulations—

“Principal Regulations” means the European Communities (Restrictive Measures against Certain Persons and Entities Associated with Usama bin Laden, the Al-Qaida Network and the Taliban) Regulations 2006 (S.I. No. 186 of 2006);

“Regulations of 2007” means the European Communities (Restrictive Measures against Certain Persons and Entities Associated with Usama Bin Laden, the Al-Qaida Network and the Taliban) (Amendment) Regulations 2007 (S.I. No. 729 of 2007);

“Regulations of 2009” means the European Communities (Restrictive Measures against Certain Persons and Entities Associated with Usama bin Laden, the Al-Qaida Network and the Taliban) (Amendment) Regulations 2009 (S.I. No. 169 of 2009);

“Regulations of 2010” means the European Communities (Restrictive Measures against Certain Persons and Entities Associated with Usama bin Laden, the Al-Qaida Network and the Taliban) (Amendment) Regulations 2010 (S.I. No. 456 of 2010).

3. Regulation 2 (as amended by the Regulations of 2007, the Regulations of 2009 and the Regulations of 2010) of the Principal Regulations is amended—
