EUROPEAN UNION (RESTRICTIVE MEASURES) (IRAN)
(AMENDMENT) REGULATIONS 2011

I, MARY HANAFIN, Minister for Enterprise, Trade and Innovation, in exercise of the powers conferred on me by section 3 of the European Communities Act 1972 (No. 27 of 1972) and for the purpose of giving full effect to Council Regulation (EU) No. 961/2010 of 25 October 2010¹, hereby make the following regulations:

1. These Regulations may be cited as the European Union (Restrictive Measures) (Iran) (Amendment) Regulations 2011.

2. The European Union (Restrictive Measures) (Iran) Regulations 2011 (S.I. No. 45 of 2011) are amended by substituting for paragraph (1) of Regulation 2 the following:

“(1) In these Regulations ‘Council Regulation’ means Council Regulation (EU) No. 961/2010 of 25 October 2010¹.”.
