DERELICT SITES (URBAN AREAS) REGULATIONS, 2011

The Minister for the Environment, Community and Local Government, in exercise of the powers conferred on him by sections 4 and 21 of the Derelict Sites Act, 1990 (No. 14 of 1990), hereby makes the following Regulations:

Citation.

1. (1) These Regulations may be cited as the Derelict Sites (Urban Areas) Regulations, 2011.

(2) These Regulations and the Derelict Sites Regulations, 1990 to 2010 may be cited together as the Derelict Sites Regulations, 1990 to 2011.

Prescription of Urban Areas.

2. The area in the administrative county of Laois indicated in Column 2 of the Schedule to these Regulations opposite the mention of the relevant administrative county in Column 1 of the said Schedule is hereby prescribed to be an urban area for the purposes of the Derelict Sites Act, 1990.
