No. 394 of 2016)), hereby make the following regulations:

1. These Regulations may be cited as the Social Housing Assessments (Summary) Regulations 2013 (Revocation) Regulations 2017.
2. The Social Housing Assessments (Summary) Regulations 2013 (S.I. No. 26 of 2013) are revoked.
