SEA-FISHERIES (NORTH WESTERN WATERS LANDING  
OBLIGATION) (AMENDMENT) (NO. 2) REGULATIONS 2023

I, CHARLIE MCCONALOGUE, Minister for Agriculture, Food and the Marine, in exercise of the powers conferred on me by sections 3 and 14 of the Sea-Fisheries and Maritime Jurisdiction Act 2006 (No. 8 of 2006) for the purpose of giving further effect to Article 15 of Regulation (EU) No 1380/2013 of the European Parliament and of the Council of 11 December 2013<sup>1</sup> (as amended by Regulation (EU) 2015/812 of the European Parliament and of the Council of 20 May 2015<sup>2</sup>, Regulation (EU) 2017/2092 of the European Parliament and of the Council of 15 November 2017<sup>3</sup> and Regulation (EU) 2019/1241 of the European Parliament and of the Council of 20 June 2019<sup>4</sup>) and effect to Commission Delegated Regulation (EU) 2023/828 of 2 February 2023<sup>5</sup> hereby make the following regulations:

1. These Regulations may be cited as the Sea-Fisheries (North Western Waters Landing Obligation) (Amendment) (No. 2) Regulations 2023.

2. The Sea-Fisheries (North Western Waters Landing Obligation) Regulations 2021 (S.I. No. 101 of 2021) are amended in Regulation 2(1) by the insertion after “19 August 2022” (as inserted by the Sea-Fisheries (North Western Waters Landing Obligation) (Amendment) Regulations 2023 (S.I. No. 47 of 2023)) in the definition of “Commission Regulation” of the following: “and Commission Delegated Regulation (EU) 2023/828 of 2 February 2023”.

3. The Sea-Fisheries (North Western Waters Landing Obligation) (Amendment) Regulations 2023 (S.I. No. 47 of 2023) are revoked.
