## STATISTICS (MONTHLY SERVICES INQUIRY) ORDER 2023

I, LEO VARADKAR, Taoiseach, in exercise of the powers conferred on me by section 25(1) of the Statistics Act 1993 (No. 21 of 1993) and, other than in relation to paragraph 2 of the Schedule to the following order, for the purpose of giving full effect to Council Regulation (EC) No. 1165/98 of 19 May 1998<sup>1</sup>, as amended by Regulation (EC) No. 1158/2005 of the European Parliament and of the Council of 6 July 2005<sup>2</sup>, Commission Regulation (EC) No. 1503/2006 of 28 September 2006<sup>3</sup>, Regulation (EC) No. 1893/2006 of the European Parliament and of the Council of 20 December 2006<sup>4</sup>, Commission Regulation (EC) No. 1178/2008 of 28 November 2008<sup>5</sup>, Commission Regulation (EC) No. 329/2009 of 22 April 2009<sup>6</sup>, Regulation (EC) No. 596/2009 of the European Parliament and of the Council of 18 June 2009<sup>7</sup> and Commission Regulation (EU) No. 461/2012 of 31 May 2012<sup>8</sup>, in so far as it relates to Annex D thereto, hereby order as follows:

1. This Order may be cited as the Statistics (Monthly Services Inquiry) Order 2023.

2. (1) In this Order -

“inquiry” means the Monthly Services Inquiry that is conducted by the Central Statistics Office for the purposes of obtaining information specified in the Schedule, including for the purposes of compliance with the Regulation, in so far as it relates to Annex D thereto;

“Regulation” means Council Regulation (EC) No. 1165/98 of 19 May 1998<sup>1</sup>, amended by Regulation (EC) No. 1158/2005 of the European Parliament and of the Council of 6 July 2005<sup>2</sup>, Commission Regulation (EC) No. 1503/2006 of 28 September 2006<sup>3</sup>, Regulation (EC) No. 1893/2006 of the European Parliament and of the Council of 20 December 2006<sup>4</sup>, Commission Regulation (EC) No. 1178/2008 of 28 November 2008<sup>5</sup>, Commission Regulation (EC) No. 329/2009 of 22 April 2009<sup>6</sup>, Regulation (EC) No. 596/2009 of the European Parliament and of the Council of 18 June 2009<sup>7</sup> and Commission Regulation (EU) No. 461/2012 of 31 May 2012<sup>8</sup>.

(2) A word or expression that is used in this Order and also used in the Regulation has the same meaning in this Order as in the Regulation, other than where the context otherwise requires.

3. This Order applies to a person who, or an undertaking that, is classified for statistical purposes under division 45 or 46 or section H, I, J, K, L, M, N, P, Q, R or S of NACE Rev. 2 set out in Annex I to Regulation (EC) No. 1893/2006 of the European Parliament and of the Council of 20 December 2006<sup>4</sup>, as amended by Regulation (EC) No. 295/2008 of the European Parliament and of the Council of 11 March 2008<sup>9</sup>, Regulation (EU) No. 70/2012 of the European Parliament and of the Council of 18 January 2012<sup>10</sup>, and Regulation (EU) 2019/1243 of the European Parliament and of the Council of 20 June 2019<sup>11</sup>.

4. A requirement on persons to whom, or undertakings to which, this Order applies to provide, for the purposes of the inquiry, information the general nature of which is specified in the Schedule, once only in relation to the months of November 2023 and December 2023, is hereby prescribed.

SCHEDULE

*Article 4*

1. Information, regarding the following, as it relates to the person or undertaking concerned, and specifying the month to which the information relates:

- (a) the total value, excluding VAT, of turnover;
- (b) the total value, excluding VAT, of turnover of sales via the internet.

2. Information on the time taken by the person or undertaking concerned to complete the questionnaire, form or other record prepared by the Director General for the collection of the information referred to in paragraph 1.
