1. These Regulations may be cited as the European Communities (Pesticide Residues) (Amendment) (No.2) Regulations 2023.

2. The European Communities (Pesticide Residues) Regulations 2008 (S.I. No. 565 of 2008) are amended in Regulation 2(1) by substituting for the definition of “Pesticide MRL Regulation”, (as amended by the European Communities (Pesticide Residues) (Amendment) Regulations 2023 (S.I. No.164 of 2023)), the following—
