# REGULATION OF LOBBYING ACT 2015 (DESIGNATED PUBLIC OFFICIALS) REGULATIONS 2024

- I, PASCHAL DONOHOE, Minister for Public Expenditure, National Development Plan Delivery and Reform, in exercise of the powers conferred on me by sections 4 and 6(2) of the Regulation of Lobbying Act 2015 (No. 5 of 2015), and having had regard to the matters specified in section 6(3) of that Act, hereby make the following regulations:
- 1. (1) These Regulations may be cited as the Regulation of Lobbying Act 2015 (Designated Public Officials) Regulations 2024.
  - (2) These Regulations shall come into operation on 1 January 2025.
- 2. A public servant in a position specified in column (3) of the table in the Schedule in the public service body specified in column (2) thereof opposite the reference number for that public service body in column (1) thereof is prescribed as a designated public official for the purposes of section 6(1)(f) of the Regulation of Lobbying Act 2015 (No. 5 of 2015).
