I, MARTIN HEYDON, Minister for Agriculture, Food and the Marine, in exercise of the powers conferred on me by section 3 of the European Communities Act 1972 (No. 27 of 1972), for the purpose of giving effect to Commission Implementing Directive (EU) 2024/2963 of 29<sup>th</sup> November 2024<sup>1</sup>, hereby make the following regulations:

1. These Regulations may be cited as the European Communities (Minimum Conditions for Examining Agriculture Plant Species) (Amendment) Regulations 2025.

2. The European Communities (Minimum Conditions for Examining Agriculture Plant Species) Regulations 2004 (S.I. No. 122 of 2004) are amended by substituting in Regulation 2 for the definition of “Directive” (as amended by the European Communities (Minimum Conditions for Examining Agriculture Plant Species) (Amendment) (No.2) Regulations 2023 (S.I. No. 518 of 2023) the following-

“‘Directive’ means Commission Directive No. 2003/90/EC of 6 October 2003<sup>2</sup> as amended by Commission Implementing Directive (EU) 2024/2963 of 29<sup>th</sup> November 2024;”.

3. The European Communities (Minimum Conditions for Examining Agriculture Plant Species) (Amendment) Regulations 2023 (S.I. No. 518 of 2023) are revoked.

## EXPLANATORY NOTE

*(This note is not part of the Instrument and does not purport to be a legal interpretation.)*

These Regulations give effect to the provisions of Commission Implementing Directive (EU) 2024/2963 of 29 November 2024 which amends Council Directive 2003/90/EC which provides for CPVO and UPOV updated protocols, in particular as regards potato, safflower, cauliflower, sprouting broccoli, Brussels sprouts, kohlrabi, savoy cabbage, white cabbage, red cabbage, watermelon, lettuce, radish, corn salad and tomato rootstocks.
