EUROPEAN COMMUNITIES (VEGETABLE SEEDS) (AMENDMENT)  
REGULATIONS 2025

I, MARTIN HEYDON, Minister for Agriculture, Food and the Marine, in exercise of the powers conferred on me by section 3 of the European Communities Act 1972 (No. 27 of 1972), for the purpose of giving effect to Commission Implementing Directive (EU) 2024/3010 of 29<sup>th</sup> November 2024<sup>1</sup>, hereby make the following regulations:

1. These Regulations may be cited as the European Communities (Vegetable Seeds) (Amendment) Regulations 2025.

2. The European Communities (Vegetable Seeds) Regulations 2001 (S.I. No. 306 of 2001) are amended by substituting in Regulation 2(1) for the definition of “Directive” (as amended by the European Communities (Vegetable Seeds) (Amendment) (No. 3) Regulations 2020 (S.I.No. 202 of 2020)) the following:

“‘Directive’ means Council Directive 2002/55/EC of 13 June 2002<sup>2</sup>, Council Directive 2003/61/EC of 18 June 2003<sup>3</sup>, Regulation (EC) No 1829/2003 of the European Parliament and of the Council of 22 September 2003<sup>4</sup>, Council Directive 2004/117/EC of 22 December 2004<sup>5</sup>, Commission Directive 2016/124/EC of 5 December 2006<sup>6</sup>, Commission Directive 2009/74/EC of 26 June 2009<sup>7</sup>, Commission Implementing Directive 2013/45/EU of 7 August 2013<sup>8</sup>, Commission Implementing Directive (EU) 2016/317 of 3 March 2016<sup>9</sup>, Commission Implementing Directive (EU) 2020/432 of 23 March 2020, Commission Implementing Directive (EU) 2020/177 of 11 February 2020 and Commission Implementing Directive (EU) 2024/3010 of 29th November 2024<sup>10</sup>”.

3. The European Communities (Vegetable Seeds) (Amendment) (No.3) Regulations 2020 (S.I. No. 202 of 2020) are revoked.

## EXPLANATORY NOTE

*(This note is not part of the Instrument and does not purport to be a legal interpretation.)*

These Regulations give effect to the provisions of Commission Implementing Directive (EU) 2024/3010 by amending the Annexes I and II to Directive 2002/55/EC as they relate to inspections for Union regulated non-quarantine pests (RNQPs) and measures intended to prevent their presence on vegetable seeds for planting.
