EUROPEAN UNION (VESSEL TRAFFIC MONITORING AND
INFORMATION SYSTEM) (AMENDMENT) REGULATIONS 2025

I, DARRAGH O'BRIEN, Minister for Transport, in exercise of the powers conferred on me by section 3 of the European Communities Act 1972 (No. 27 of 1972) and for the purposes of giving effect to Commission Delegated Directive (EU) 2025/811 of 19 February 2025¹, hereby make the following regulations:

1. These Regulations may be cited as the European Union (Vessel Traffic Monitoring and Information System) (Amendment) Regulations 2025.

2. Regulation 2 of the European Communities (Vessel Traffic Monitoring and Information System) Regulations 2010 (S.I. No. 573 of 2010) is amended by substituting for the definition of “Directive” the following:

“‘Directive’ means Directive 2002/59/EC of the European Parliament and of the Council of 27 June 2002², as amended by—

- (a) Directive 2009/17/EC of the European Parliament and of the Council of 23 April 2009³,
- (b) Directive 2009/18/EC of the European Parliament and of the Council of 23 April 2009⁴,
- (c) Commission Directive 2011/15/EU of 23 February 2011⁵,
- (d) Commission Directive 2014/100/EU of 28 October 2014⁶,
- (e) Regulation (EU) 2019/1243 of the European Parliament and of the Council of 20 June 2019⁷, and
- (f) Commission Delegated Directive (EU) 2025/811 of 19 February 2025¹;”.
