STATISTICS (BUSINESS ENERGY USE SURVEY) (AMENDMENT) ORDER 2025

I, MICHEÁL MARTIN, Taoiseach, in exercise of the powers conferred on me by section 25(1) of the Statistics Act 1993 (No. 21 of 1993) and for the purpose of giving further effect to Regulation (EC) No. 1099/2009 of the European Parliament and of the Council of 22 October 2008¹, as amended by Commission Regulation (EU) No. 844/2010 of 20 September 2010², Commission Regulation (EU) No. 147/2013 of 13 February 2013³, Commission Regulation (EU) No. 431/2014 of 24 April 2014⁴, Commission Regulation (EU) 2017/2010 of 9 November 2017⁵, Commission Regulation (EU) 2019/2146 of 26 November 2019⁶, Commission Regulation (EU) 2022/132 of 28 January 2022⁷ and Commission Regulation (EU) 2024/264 of 17 January 2024⁸, in so far as it relates to Annex B thereto, hereby order as follows:

- 1. This Order may be cited as the Statistics (Business Energy Use Survey) (Amendment) Order 2025.
- 2. The Statistics (Business Energy Use Survey) Order 2024 (S.I. No. 15 of 2024) is amended
 - (a) in Article 2(1), in the definition of "Regulation", by the substitution of ", Commission Regulation (EU) 2022/132 of 28 January 2022⁷ and Commission Regulation (EU) 2024/264 of 17 January 2024⁸" for ", and Commission Regulation (EU) 2022/132 of 28 January 2022⁷",
 - (b) by the substitution of the following Article for Article 3:
 - "3. This Order applies to a person who, or an undertaking that, is classified for statistical purposes under any section of NACE Rev. 2.1 set out in Annex I to Regulation (EC) No. 1893/2006 of the European Parliament and of the Council of 20 December 2006⁹, as amended by Regulation (EC) No. 295/2008 of the European Parliament and of the Council of 11 March 2008¹⁰, Regulation (EU) No. 70/2012 of the European Parliament and of the Council of 18 January 2012¹¹,
